

# Bhutan: A Journey to the Himalayas May 11–25, 2024

Bhutan's alpine pastures, peaks, forests, lakes and flowers make it a paradise for any active traveler all the while surrounded by the immense Himalayan mountain range. Religious beliefs are woven in all aspects of Bhutanese life. Prayer flags flutter on hillsides offering up prayers to benefit all beings

**Bhutan** or the "Land of the Thunder Dragon" is a country of

lush green valleys fed by bountiful rivers and the only carbon-

sprawling forests, venerated monasteries, overpowering fortresses;


flags flutter on hillsides offering up prayers to benefit all beings by households flying a small white flag on the roof indicating an offering to appease the local god.

As an alternative to measuring GDP, since the 1970s Bhutan has adopted Gross national happiness (GNH) as a measure of economic and moral progress of the country and the results are woven into the fabric of everyday life.



Historian **Andrew Bernstein** has taught at Lewis & Clark for twenty-four years. Andy has traveled widely across Asia including leading a number of overseas student programs. # **Program itinerary**

#### May 13 & 14, 2024: Travel to Bhutan

Flight to Paro, Bhutan.

Note that flights to Paro Airport (PBH) are either via Bangkok (Thailand) on Druk Air or via New Delhi (India) on Air India or Druk Air. Travelers will typically need to stay a night in Bangkok/ New Delhi to catch an earlier morning flight to Paro the next morning. Pre and/or post-trip stopovers in either Bangkok or New Delhi can also be arranged via the tour operator.

### May 15: Arrive Paro/ Transfer to Thimphu

Arrive Paro, Bhutan (flights arranged by guests). Met on arrival and transferred to your hotel in Thimpu.

Depending on your arrival time, visit the Tashichho Dzong. Dzongs are fortress-monasteries that dot the Bhutanese landscape. The Tashichho Dzong is located on the western bank of the Wang Chu and is Bhutan's most stately and arguably the most impressive building. It is also the seat of the Drukdesi or 'Dharma Raja' which is the head of Bhutan's civil government since 1907.

Gather for an orientation and presentation by History Professor Andrew Bernstein followed by a welcome dinner.

Altitude: 2,350 m / 7,709 ft. Overnight: <u>Norkhil Boutique Hotel</u> (B, L, Welcome Dinner)

### May 16: Tour of Thimphu

Visit the site of the huge statue of Buddha Dordenma which offers unobstructed views over the capital. The fifty-one meter tall statue commands the entry to the Thimphu Valley and the massive threestoried base houses a large chapel containing thousands of Buddha statuettes. Later, visit Zorig Chusum. This arts and crafts institute promotes the traditional arts and crafts of Bhutan.

Dig in as we gather as a group to discuss your initial questions about Bhutan and Buddhism with History Professor Andrew Bernstein. *Overnight: Norkhil Boutique Hotel (B, L, D)* 

#### May 17: Thimpu – Khotokha

After breakfast, drive to Khotokha via the Dochu La Pass On clear days the views of the Himalaya range is spectacular. Tradition calls for a stop at the beautiful 108 chortens built on the hill by the Queen Mother for the security and well-being of the King of Bhutan.

Arrive at Khotokha — a large glacial valley and home to subsistence farmers, monasteries and hermitages. With breathtaking views, these sacred sites are visited by pilgrims from all over Bhutan and beyond. Enjoy a few hours of walking to visit several monasteries. This is the best way to get an understanding of the area and its importance. You may have an opportunity to interact with locals, pilgrims and monks. Arrive at your tented campsite set up for you.

Altitude: 3,088m/10,130ft. Overnight: Tented Camp (B, L, D)\*

\*The tented accommodations are comfortable and set up for tourists and contain portable beds, blankets and pillows, a sanitized communal bathroom and a shower tent (exclusively set up for the group complete with towels, soap and water), experienced crew members and hearty meals.

#### May 18: Khotokha

The untouched beauty of deep pine forests in Khotokha offers possibilities for trekking to sacred sites, remote villages bound by scenic beauty. There are many *drupchus* (holy water springs) and *menchus* (healing water) believed to have mystical healing powers. Witness and participate in a full reconstruction of the popular Tshechu dance — a traditional Bhutanese dance of highly stylized masked dancers rituals. Attendees adorned in astounding color gather from around the village to receive blessings from this sared ceremony from the monks. This is a great way for travelers to interact with the locals. *Overnight: Tented Camp (B, L, D)* 

#### May 19- Trek to Gogona and drive to Gangtey

This hike begins from the beautiful Khotokha valley towards the Phobjikha valley. This moderate hike will stop at villages along the way, passing through meadows and fields of juniper, magnolia and rhododendrons which are typically in full bloom in May. The total hiking time including stops is estimated to take up to 6 hours.

Arrive at Gogona which is a small village with an amazing monastery under the care of the Gangtey Gompa. After a brief rest stop depart by road to Gangtey. Gangtey is a glacial valley on the western slopes of the Black Mountains and a designated conservation area and one of the most important wildlife preserves in Bhutan.

Check into your hotel and later visit the Gangtey Gonpa Monastery complex. This complex of five temples is one of the two main centers of the Nyingmapa school of Tibetan Buddhism in Bhutan.

Altitude – Gangtey: 3,000 m / 9,842 ft Overnight: <u>Dewachen Hotel</u> (B, L, D)

#### May 20: Gangtey

Visit local Bhutanese farm houses that are ever-present in this area. Immerse yourself with the local family to understand their lifestyle and participate in a cooking and tasting demonstration. Later, visit a community school in the village and interact with the local children.

Later, join the evening prayer session in a monastery which is home to approximately 250 novice monks. This experience is quite meditative as the monks chant their prayers in unison. Guests are invited to chat with the novice monks after the prayer session before returning to the hotel.

Overnight: Dewachen Hotel (B, L, D)

#### May 21: Gangtey – Punakha

Depart for Punakha. Enjoy a 20 minute easy walk through the village to the Divine Madman's Monastery or Chimi Lhakhang which is famous for its fertility shrine. Later visit the Punakha Dzong located on the island of the Pho Chhu (male) river and the Mo Chhu (female) river. Couples looking to having children are drawn to this area to receive blessings for a safe delivery of their offspring.

Gather as a group for a facilitated discussion about Bhutan with Andrew Bernstein.

The remainder of the day is at your own leisure to explore. Altitude: 1300 m / 4265 ft Overnight: <u>Zhingkham Resort</u> (B, L, D)



#### May 22: In Punakha

Take an invigorating hike to Khamsum Yulley Namgyal Chorten (commonly known as stupas). This is a fine example of Bhutanese architecture and artistic traditions. This hour long hike through a moderately inclined trail is surrounded by pine trees offering beautiful views of the Punakha Valley below.

Return to the hotel where the remainder of the afternoon is at your own leisure. *Overnight: Zhingkham Resort (B,L,D)* 

### May 23: Drive to Paro

Return to Paro and visit the Paro Dzong and National Museum of Bhutan. The Paro Dzong is one of the most popular and well known dzongs in Bhutan and is also the administrative seat of the district.

The National Museum of Bhutan houses over 3,000 works of Bhutanese art, rich holdings of various creative traditions and disciplines that represent a remarkable blend of the past with the present.

Altitude: 2250 m / 7382 ft Overnight: <u>Tenzinling Resort</u> (B, L, D)

### May 24: Taktsang Monastery (Tiger's Nest)

Depart from your hotel for a hike to Taktsang Monastery (approximately 4.5 hours with multiple stops). Perched on the side of a vertical cliff at an altitude of 3,000 meters (9,800 feet), this beautiful monastery also known the Tiger's Nest is the most famous and most recognized symbol of Bhutan.

The monastery is a pilgrimage site for both tourists and locals and the journey up to the monastery is filled with spiritual bliss. Guests are not expected to complete the full hike but rather enjoy the journey as far as they can.

Join the group for a farewell dinner. Overnight: Tenzinling Resort (B, L, D)

#### May 25: Depart Paro

After breakfast, transfer to the airport for your flight to Bangkok or New Delhi. On arrival connect to your flight home\*

\*Depending on your flight arrangements, hotel accommodations can be arranged in New Delhi or Bangkok. Please contact the tour operator should you require any assistance.

# Ground costs

**Bhutan Visa:** Visa for Bhutan is processed prior to arrival in the country by the tour operator and issued a few weeks prior to arrival date. Proof of trip insurance is mandatory in to apply for a Bhutan entry visa and will be requested by the tour operator. Trip insurance is not included in the cost of this trip and can be purchased independently by the guest.

- Mandatory trip insurance. Proof of trip insurance is mandatory to obtain a Bhutan entry visa and will be requested by the tour operator.

- PCR tests (currently all COVID entry requirement into and out of Bhutan have been relaxed. However, guests should be prepared to show proof of being fully vaccinated if requested).

#### Level of difficulty: Easy to moderate. Traveling in areas of high altitude and mountain/ hill ranges.

Travel will be in a combination of coaches and small vehicles over winding mountain passes. You will be traveling in altitudes ranging from 4,200 feet above mean sea level to 10,000 feet above mean sea level. There will be days that involve moderate hiking on pathways of varying topography and we expect guests to be in generally good physical condition and be able to walk without a full time walking aide (canes, walkers, wheelchairs). Accommodations in Bhutan are often built on hillsides and changing landscape requiring stairs and ramps and guests should not expect conveyances that they may be used to in their country of origin. Also note that part of your itinerary includes tented accommodations (cot beds) with communal bathrooms. Every effort will be made to ensure your comfort however it will be the responsibility of the guest to advise the tour operator and Lewis & Clark College regarding any concerns you may have. Please consult with your doctor regarding this trip, its length and location and share this brochure with them.

**RESERVATIONS AND PAYMENTS:** A prepayment non-refundable deposit \$1,000 per along with a completed and signed Tour Reservation Form, and copy of passport are required in order to confirm your reservation. Upon receipt of these forms and your deposit, we will confirm your trip. This Agreement. The signed Reservation form and the signed Credit Card Authorization section of the Tour Reservation Form are all part of your agreement with us.

The balance of your Tour cost is due of 90 days prior to departure.

**TRAVEL INSURANCE:** We strongly recommend that you purchase trip cancellation insurance. In the event that you must cancel your participation in a Tour, trip cancellation insurance may be the only source of reimbursement. Trip cancellation insurance is available for comprehensive coverage of such expenses in conjunction with cancellation due to illness or accident, and damaged or lost luggage.

If a flight or other delay for any reason prevents you from joining the Tour on the Tour start date, you will be considered a no-show. No refunds will be available, but you may join the Tour late if you wish. Commercial airline tickets must be paid in full at the time of ticketing. In such case, our liability shall be strictly limited to refund of the recoverable cost of any unused portion of the tour. Should you decide not to participate in certain parts of the tour or use certain goods included in the tour, no refunds will be made for those unused parts of the tour or goods.

**MEDICAL PROXY:** If you are unable to authorize your own medical attention and treatment, you authorize Immersion Journeys or its subcontractors or agents to authorize medical attention and treatment on your behalf. You agree to hold harmless and release Immersion Journeys from any liability for medical attention arranged or not arranged on your behalf. Immersion Journeys assumes no liability regarding provision of medical care or evacuation services.

CHANGES: Changes in this Agreement may be made only in writing, signed by an officer of Immersion Journeys.

**BINDING ARBITRATION:** Any dispute concerning, relating or referring to this Agreement, the brochure or any other literature concerning the Tour, or the Tour itself, shall be resolved exclusively by binding arbitration pursuant to the Federal Arbitration Act, 9 U.S.C. Sections 1-16, either according to the then existing Commercial Rules of the American Arbitration Association (AAA) or pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will be governed by substantive (but not procedural) State of New York law and will take place in New York City, New York. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. Please understand that by agreeing to these terms and conditions, the participant and Immersion Journeys are waiving the right to a trial by jury. Any arbitration commenced against Immersion Journeys must be on behalf of only the signatory to this Agreement and his or her immediate family members who travelled with signatory, such as a spouse or child. Under no circumstances can participant be part of a class or other joint action.

By signing the Tour Registration form, you agree to the terms of this Terms and Conditions, Release of Liability, Assumption of Risk and Binding Arbitration Agreement. Your Agreement extends to any tour to which you may transfer. If you party includes a person under 18, then you represent that you are that person's parent or legal guardian.
