Lezlie Harrison: WBGO Host of Come Sunday

Lezlie Harrison, vocalist extraordinaire, is always in a state of development, always raising the bar higher, pushing the limits of her God-given vocal gift. As a vocalist, she is both bold and subtle in her approach to the music she loves. Her vulnerability attends to the fragile matters of our collective human experience, while her optimism inspires us to rise above any of life's tribulations, to rejoice. Whether taking on a classic Jazz tune, Blues, Gospel, Soul, tracks from the American Song Book, or an original composition, Ms. Harrison imbues each note, each line of a song with her very own styling and personalized delivery. She carries that over to her regular spot on WBGO, the global leader in Jazz

radio, where she is a regular curator and presenter, revealing the love and pride with which she regards America's music. A permanent fixture on the New York and global Jazz scene, Lezlie Harrison is among the three founding members of New York's world-renowned JAZZ GALLERY that includes the late Dale Fitzgerald and trumpeter Roy Hargrove.

On occasion Lezlie lends her regal presence to the stage as an actress, bringing to those endeavours, the same organic sensibility that she brought to the runways and photo studios of Paris some years a back. A product of two contrasting communities -- New York and North Carolina, Lezlie Harrison has been shaped by both and educated by her global experience.



Wayne Winborne, Executive Director of the Institute of Jazz Studies. Rutgers University

Wayne Winborne is executive director of the Institute of Jazz Studies (IJS) at Rutgers University-Newark, the largest and most comprehensive archive and library of jazz and jazz-related materials in the world.

Winborne is also an assistant professor in the Arts, Culture, and Media department and is a frequent presenter on jazz, art and culture, democracy, civic engagement, racial reckoning, non-profit management, and race and intergroup relations. He has numerous publications and is editor of a three-book series on race and intergroup relations. He is a consultant to corporate, small business, and non-profit clients on strategic planning, fund development,

DEI, multicultural marketing, and dialogue facilitation. Winborne has produced several recordings for the MaxJazz, HighNote, Satchmo, and Savant labels. He has also written and produced short documentaries and has won a Cine Golden Eagle award and two Telly awards for *Insider Game* and *Insider Game* 2, which focused on Hispanic Americans in corporate board rooms. The short documentary *Stepping Up* examined caregiving among jazz musicians was an official selection of DOCNYC 2016, the nation's largest documentary film festival.

He has been honored by the Feminist Press with its Crossing Borders award, the Brooklyn Club of the National Association of Negro Business and Professional Women's Clubs, Inc., with its Man of Distinction award, the Asian American Federation of NY with its Spirit of Asian America award, by FraserNet with its Corporate Professional of the Year award, and by the National Council for Research on Women with its Diversity Champion Award. Winborne holds degrees from Stanford and New York University.



Stefon Harris, Musician and Grammy-nominee/ Educator / Developer / Thought Leader

Stefon Harris is a four-time Grammy-nominated jazz vibraphonist, educator, app developer, and thought leader. He has been heralded as one of the most important artists in jazz" (Los Angeles Times) and is a recipient of the prestigious Doris Duke Artist Award and the Martin E. Segal Award from Lincoln Center. He has been named Best Mallet Player eight times by the Jazz Journalist Association and Best Vibes Player in DownBeat Magazine's Critics Poll. Harris currently tours with his Grammy-nominated band, Blackout, and has released eleven albums as a leader.

He has also recorded and performed with The Classical Jazz Quartet, Kenny Barron, Ron Carter, Lewis Nash, the SFJAZZ Collective, Joe Henderson, Wynton Marsalis, Milt Jackson, Lionel Hampton, Herbie Hancock, Wayne Shorter, Bobby

Hutcherson, Cassandra Wilson, Diana Krall, Max Roach, Chaka Khan, Kurt Elling, Buster Williams, Dianne Reeves, Common, and Pablo Zeigler.

Along with performing, Harris has taught at universities throughout the world, led curriculum development at the Brubeck Institute, served as a part of the jazz faculty at New York University, and formerly served as the Associate Dean and Director of Jazz Arts at Manhattan School of Music. He is currently Artistic Advisor of Jazz Education at the New Jersey Performing Arts Center (NJPAC) and is a tenured Associate Professor of Music at Rutgers University – Newark.

In 2013, he founded The Melodic Progression Institute (MPI) and created a revolutionary ear training app called *Harmony Cloud* which is widely used by musicians across multiple genres.

As a thought leader, Harris leads transformative presentations on corporate leadership and team empowerment for Fortune 100 companies using jazz as a metaphor. His 2012 TED Talk, There Are No Mistakes on the Bandstand," has gained nearly 900,000 views. Through these presentations, Harris and his band are committed to the proliferation of empathy through the arts and empowering others with the necessary tools to articulate their authentic voices through music.

Day 1- Sept 21, 2025- Depart U.S.

Depart New York JFK in the morning (etd 06:45am).

Arrive in Istanbul and transit to your connecting flight departing at 01:45am.

Day 3 – Sept 23- Cape Town City Tour, Table Mountain, Bo Kaap

Tour of Cape Town. On a clear day from the summit of Table Mountain you get spectacular views of the City, its Waterfront, Camps Bay, the majestic Hottentots Holland Mountains to the East and the mountains of the Cape Peninsula all the way down to Cape Point to the south. The Table Mountain cableway, a must for all visitors to the Cape (weather permitting), boasts revolving floors, giving passengers a 360-degree view. After descending the mountain, you will depart on a tour of the "Mother City" taking in Signal Hill – where the Noon Day Gun is fired at midday.

Enjoy a Cape Malay lunch in Bo-Kaap followed by a walking tour of this brightly painted neighborhood that were once homes of the Muslim population. Today, this neighborhood is becoming gentrified, but the vibe remains.

Evening private jazz concert while enjoying exquisite South African wines and hors oeuvres.

Overnight: The Cullinan Hotel (Breakfast, Lunch, evening hors oeuvres)

Day 4 - Sept 24- Cape Peninsula Tour

The tour includes a scenic drive along the Atlantic Coast with stop sat Boulder's Beach (penguin colony), Chapman's Peak and finally the Cape of Good Hope and Cape Point Nature Reserve with its variety of fauna and flora. The reserve is one of the world's largest breeding grounds for tortoises and is nothing short of a spectacular sight with its stone cliffs, fynbos, beautiful bay and beaches. It is a natural wonderland.

Evening at your own leisure to enjoy some of Cape Town's amazing culinary establishments on the V&A Waterfront.

Overnight: The Cullinan Hotel (Breakfast, Lunch)

Day 5 – Sept 25- Cape Winelands and Departure for Johannesburg

Breakfast at leisure and check out. Depart for a half day visit to the renowned wine lands of Stellenbosch. Depart from the hotel to the Cradle of Humankind. Embark on an unforgettable journey of storytelling as you walk in the footsteps of our hominin ancestors and learn more about the story of human origins in Africa. Guided by a specialist, visitors will be guided through the excellent Malapa Museum which was curated by the famous paleo-anthropologist, Prof. Lee Berger. This guided tour takes about one hour. After the museum visit, visitors board an open game drive vehicle for a transfer to the nearby Motsetse Cave. At Motsetse, the specialist guide will cover geology, cave formation and the fossilization process. The tour then proceeds into the cave entrance to observe fossils visible in the breccia and layers of blue-green algae visible in the dolomite.

Enjoy the second night of the annual Joy of Jazz Festival (entry tickets included).

By signing our tour reservation form, or otherwise indicating your assent in writing, you agree to the terms and conditions set forth in this document. These terms and conditions apply to the Tour, the itinerary for the Tour and payment for the Tour.

- 1. **INTRODUCTION**: These are the terms and conditions applicable to the tour packages provided by Immersion Journeys LLC (collectively "Immersion Journeys", "we", "us" and "our"). The terms "client" "you" and "your" refer to each person who purchases and/or uses a tour package provided by Immersion Journeys.
- 2. **RESERVATIONS AND PAYMENTS:** A non-refundable prepayment deposit of \$1,995 per person, along with a completed and signed Terms and Conditions, Release of Liability, Assumption of Risk [and Binding Arbitration] Agreement (Agreement) and Credit Card Authorization (if paying by cc) are required in order to confirm your reservation. Upon receipt of these forms and your deposit, we will confirm your trip. This Agreement, Ithe signed Reservation form and the signed Agreement, and the signed Credit Card Authorization Form are all part of your agreement with us.

The balance of your Tour cost is June 24, 2025 prior to departure.

- 3. TRAVEL AND EVACUATION INSURANCE: We strongly recommend that you purchase trip cancellation insurance. In the event that you must cancel your participation in a travel Tour, trip cancellation insurance may be the only source of reimbursement. Trip cancellation insurance is available from multiple sources for comprehensive coverage of such expenses in conjunction with cancellation due to illness or accident, and damaged or lost luggage. We will send you an application upon receipt of your reservation. In addition, medical evacuation coverage may be required as a condition of booking.
- 4. CANCELLATION AND REFUND POLICY: Our cancellation charges are based on the stringent payment policies of our suppliers of local services and therefore represent a reasonable estimate of our loss. Cancellation charges are expressed as a percentage of your total trip cost (excluding commercial airfare) and also depend on the day you cancel and the day of your scheduled departure from your home. Our cancellation charges are in addition to whatever the airline may charge you:

There is no refund for unused portions of a tour once it has commenced, and you are solely responsible for costs incurred by you due to missed, cancelled or delayed transportation. Your decision not to participate on the Tour due to State Department or Centers for Disease Control advisories or warnings, fear of travel, or for any other reason will be deemed a cancellation. If a flight or other delay for any reason prevents you from joining the Tour on the Tour start date, you will be considered a no-show. No refunds will be available, but you may join the Tour late if you wish and if it is feasible to do so.

Commercial airline tickets must be paid in full at the time of ticketing. Airline cancellation charges are set forth on the invoice.

- 5. NOT INCLUDED: Taxes; passport, visas and associated fees; personal expenses such as laundry, telephone calls and Internet access; accident/sickness, trip cancellation, and baggage insurance; gratuities to ship and hotel personnel; optional sightseeing excursions; baggage charges on aircraft; local departure air/airport tax(es); airfare and associated local taxes, airport facility and security taxes and federal inspection fees not listed as included in the travel Tour; transfers and baggage handling to/from airport/hotel/ship on day(s) of arrival and/or departure; any overnight on land due to flight schedule(s); meals, alcoholic or other beverages and all other services not specifically mentioned as included in the travel Tour.
- 6. AIRFARE: Airfare is subject to change and availability and, depending on the fare basis, likely is nonrefundable. Your airline ticket constitutes a contract between you and the airline, even if purchased through Immersion
- 7. BAGGAGE: Luggage allowance policies are set by the airlines and may change without notice. Baggage is at owner's risk throughout the trip. Airlines, buses, vans and other modes of transportation may all have weight and size restrictions on luggage. It is your responsibility to comply with all baggage restrictions.
- 8. PRICE INCREASES: Prices may be increased because destination countries occasionally increase their VAT or other taxes. In addition, some suppliers impose energy surcharges or other price increases. Prices are also subject to increase due to currency fluctuations. - 12. OTHER TAXES AND FEES: Some governments charge departure taxes and/or fees. These fees are the responsibility of each passenger traveling to the designated country and are not included unless stated.
- 13. FORCE MAJEURE: Immersion Journeys assumes no responsibility for any personal injury, property damage, financial or other loss, accident, delay, inconvenience, or irregularity which may be occasioned by reason of any matter beyond our control including but not limited to a delay or cancellation of a flight that causes you to miss all or any portion of the Tour, acts of God, acts or orders of government, epidemics, war, terrorist acts, riots, disaster, weather events, or strikes.
- **14. INDEMNIFICATION:** You shall indemnify, defend and hold harmless Immersion Journeys and its officers, employees, directors, suppliers and agents, in their individual capacities or otherwise, from and against any Losses arising out of: (i) your negligence; (ii) your failure to comply with applicable law; or (iii) your failure to comply with these terms and conditions.
- **15. PHOTO RELEASE:** You consent to our use of pictures or video of you in our marketing materials without compensation.
- 16. PHYSICAL ACCESSIBILITY: All Tours require physical independence and mobility. Any physical or mental condition that may require special medical attention or physical assistance (for example, the need for a wheelchair) must be reported in writing when you make your reservation. Participants must be able to embark or disembark vans or motor coaches alone or with minimal assistance from your traveling companion and climb stairs and step over raised thresholds without assistance. Participants requiring assistance must travel with a companion who will be responsible for handling equipment. Please understand that the Americans with Disabilities Act does not apply outside the United States.
- 17. CONDUCT DURING TOUR: You are also responsible for respecting the authority and following the directions of the tour guide and the laws of the countries in your itinerary. We may exclude you from participating in all or any part of the tour if, in our sole discretion, your condition or behavior renders you unfit for the tour or unfit for continuation once the tour has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of tour services, or may constitute a hazard or embarrassment. In such case, our liability shall be strictly limited to refund of the recoverable cost of any unused portion of the tour. Should you decide not to participate in certain parts of the tour or use certain goods included in the tour, no refunds will be made for those unused parts of the tour or goods.
- 18. MEDICAL PROXY: If you are unable to authorize your own medical attention and treatment, you authorize Immersion Journeys or its subcontractors or agents to authorize medical attention and treatment on your behalf. You agree to hold harmless and release Immersion Journeys from any liability for medical attention arranged or not arranged on your behalf. Immersion Journeys assumes no liability regarding provision of medical care or evacuation services.
- 19. CHANGES: Changes in this Agreement may be made only in writing, signed by an officer of Immersion Journeys.

- 20. SUPPLEMENTAL RELEASE: This Supplemental Release is supplemental to and not in limitation of the Agreement and Release from Liability, Assumption or Risk and Arbitration Agreement ("Release") I/we previously signed. Except as modified herein, that Release remains in full force and effect. I understand that Immersion Journeys, LLC. ("Immersion Journeys") does not own, operate, control or supervise any person or entity which provides hot air balloon trips or hot air balloon equipment and that it makes no representations whatsoever as to the adequacy or safety of any such person or entity or of any such equipment. In addition, I understand that Immersion Journeys is giving me information about this trip, or booking it only as a courtesy to me. I understand there are various risks of injury, inconvenience and death associated with hot air ballooning. These include, but are not limited to, crashes, uncontrollable wind currents which, among other things, could cause hard landings (dragging of the balloon which in turn could cause injury or death), the possibility of a fire as a result of a drag or crash, landing in an area different from that anticipated, defective equipment, etc. I assume all such risks and specifically release Immersion Journeys from any and all claims of negligence, gross negligence, breach of contract or any other claim with regard to my hot air ballooning trip. I further understand that medical aid may be unavailable during the course of my balloon safari, evacuation to any medical facility difficult and lengthy, and that any such facility (or medical personnel) may not be of the quality of facilities or medical personnel in the United States.
- 21. BINDING ARBITRATION: Any dispute concerning, relating or referring to this Agreement, the brochure or any other literature concerning the Tour, or the Tour itself, shall be resolved exclusively by binding arbitration pursuant to the Federal Arbitration Act, 9 U.S.C. Sections 1-16, either according to the then existing Commercial Rules of the American Arbitration Association (AAA) or pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will be governed by substantive (but not procedural) State of New York law and will take place in New York City, New York. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable. Please understand that by agreeing to these terms and conditions, the participant and Immersion Journeys are waiving the right to a trial by jury. Any arbitration commenced against Immersion Journeys must be on behalf of only the signatory to this Agreement and his or her immediate family members who travelled with signatory, such as a spouse or child. Under no circumstances can participant be part of a class or other joint action.
- **22. ADDITIONAL RELEASES.** Some hotels, lodges, local safari operators, airlines and other suppliers might require you to sign their own releases as a condition of your utilizing their services. Upon request, we would be happy to request a copy of those releases from those suppliers.

By signing the Tour Registration form, you agree to the terms of this Terms and Conditions, Release of Liability, Assumption of Risk, Supplemental Release and Binding Arbitration Agreement. Your Agreement extends to any tour to which you may transfer. If you party includes a person under 18, then you represent that you are that person's parent or legal guardian.
